## **WHAT IS THE GM SUPPLIER DISCOUNT PROGRAM?**

The GM Supplier Discount program is a partnership benefit offered to employees of companies that supply parts, services, or materials to General Motors. It is part of GM's broader recognition of the businesses that help build its vehicles. Instead of offering a vague membership discount, GM provides a structured pricing model. Eligible participants receive a price that is predetermined, usually based on the vehicle's invoice price minus a

small holdback, plus a fixed administrative fee. This price is often referred to as the “Supplier Price.”

To verify eligibility and apply the discount, GM requires a unique authorization code. This code is generated using your company’s specific identifier from the **GM Supplier Discount company code list**. Without this code, dealers cannot process the discount. The list itself is maintained by GM and provided to participating companies, who then share it with their employees.

## How Does the

# Company Code Work?

Each eligible company has a unique alphanumeric code. For example, a major tier-one supplier like “ABC Auto Parts” might have a code like “SUP12345.” This code is not a password; rather, it is the key that ties the employee to the company’s participation in the program. When you visit a GM dealership, you will need to provide this code along with proof of employment (such as a pay stub or company ID) to the dealer. The dealer enters the code into GM’s system (often called the “Supplier Code” field in

the GM GlobalConnect system) to verify your eligibility and generate your discount authorization number, which you use to finalize the purchase.

It is important to note that the **GM Supplier Discount company code list** is proprietary. It is not publicly posted on GM's website because it is intended for employees of specific partner companies. However, many companies share this information internally via their HR portals, intranet, or benefit bulletins.

## **WHO IS ON THE GM SUPPLIER DISCOUNT COMPANY CODE LIST?**

The list includes a wide range of businesses.

Typically, these are companies that have a direct supply relationship with GM, but the definition has expanded over the years. Common categories include:

- **Automotive Parts Manufacturers:**  
Companies that produce components like engines, transmissions, electronics, brakes, and interior parts.
- **Tooling and Equipment Suppliers:**  
Businesses that provide machinery, dies, and molds used in GM factories.
- **Logistics and Transportation Firms:**  
Companies that handle shipping,

warehousing, and supply chain management for GM.

- **Engineering and Design**

**Firms:**

Contractors that provide design, testing, and engineering services.

- **Technology Partners:**

Software and hardware companies that supply infotainment systems, navigation, or telematics.

- **Service Providers:**

Companies offering maintenance, janitorial, security, or other services at GM facilities.

massive corporations. Many smaller businesses that hold contracts with GM are also included. If you are unsure whether your employer is on the **GM Supplier Discount company code list**, the best approach is to ask your human resources department or check your employee benefits portal.

## **HOW TO FIND YOUR COMPANY'S CODE ON THE GM SUPPLIER DISCOUNT COMPANY CODE LIST**

Finding your specific company code requires a bit of detective work, but the process is straightforward once you know where to look. Follow these steps:

It is not limited to

1. **Check Your Company's Internal Resources:**

Most companies that offer this benefit will have a dedicated page on their intranet or employee portal. Look for terms like "GM Supplier Discount," "Vehicle Purchase Program," or "GM Employee Pricing." The code is often listed there.

2. **Contact Human Resources:** If you cannot find the information online, reach out to your HR or benefits team. They can confirm your company's eligibility and provide the

correct **company code.**

3. **Ask Your Manager or Colleagues:**

Sometimes the code is widely known among employees who have used the program. A quick question in a team meeting or company chat group can yield results.

4. **Visit a GM Dealer with Your Employer Information:**

Some dealerships have access to a list of eligible companies. If you bring proof of employment, the dealer may be able to look up your company's code. However, this is

not always reliable, as dealerships are not given the full list.

5. **Use the GM Supplier Website:** GM has a dedicated portal for supplier employees. If your company is enrolled, you may be able to register at **gmfamilyfirst.com** (for example) using your company email address. The system may automatically recognize your employer and assign a code.

Remember, each code is unique to the company. Using an incorrect code will result in rejection. Double-check the

spelling and format—codes are often case-sensitive and may include hyphens.

## What If My Company Is Not on the List?

If after checking all resources you find that your employer is not an eligible supplier, do not despair. There are other GM discount programs you may qualify for:

- **GM Employee Discount:** Available to GM employees and their families.
- **GM Military**

active duty, veterans, and their families.

- **GM College Discount:** For recent graduates and current students.
- **GM Credit Card Rewards:** Earn points that can be redeemed for discounts.
- **GM Friends & Family:** Some employees can share their discount codes with a limited number of friends.

Even if your company is not on the **GM Supplier Discount company code list**, you may still save significantly through these other programs.

## GM SUPPLIER DISCOUNT COMPANY CODE

Once you have your company code, the process to purchase a vehicle is simple:

1. **Research and Choose a Vehicle:** Use GM's official Build & Price tool to see the MSRP. Note that the supplier price is not shown publicly, but your dealer can provide it.
2. **Locate a Participating Dealer:** Most GM dealers accept supplier discounts, but it is wise to call ahead and confirm they participate.
3. **Provide Your**

At the dealership, tell the salesperson you want to use the GM Supplier Discount. Provide your company code and proof of employment (e.g., pay stub, badge, or a letter from HR).

**Number:** The dealer will enter your code into GM's system to generate a unique authorization number. This number is valid for a set period (often 30 days) and is tied to a specific vehicle.

**Important:** The supplier discount is on the vehicle price, not on taxes, fees, or accessories. You may still be able to negotiate the value of your trade-in separately. Also, not all models are eligible. High-demand, low-volume vehicles (like the Corvette Z06 or certain Cadillac models) may be excluded from the program.

## **BENEFITS OF USING THE GM SUPPLIER DISCOUNT**

Why go through the effort of obtaining a company code? The advantages are compelling:

- **Transparent Pricing:** You know the price upfront without haggling. It is typically 4% to 6% below MSRP, which can be thousands of dollars off a \$40,000 SUV.
- **No High-Pressure Tactics:** Supplier pricing removes much of the negotiation stress. You are getting a fair deal from the start.
- **Stackable with Rebates:** In many cases, you can combine the supplier discount with manufacturer rebates, finance offers, and loyalty bonuses. Check terms carefully—some rebates may not be stacked.
- **Family Eligibility:** Most programs allow extended family (spouse, children, parents, in-laws) to also use the code, subject to limitations. Check your company's policy.
- **Multiple Purchases:** Some companies allow unlimited use of the code

for different vehicles over time, while others limit it to one per year.

Using the correct code from the **GM Supplier Discount company code list** is the only way to access these benefits. Even a small mistake—like a missing letter—can invalidate the discount.

Yes. Each company has one standard code. However, some large suppliers have multiple codes for different divisions. Use the code specific to your location or division.

First, confirm you have the correct code. Check for typos. If it still fails, contact your HR department to ensure the company's enrollment is active. Sometimes companies drop out of the program or codes change. The dealer may also need to call GM's supplier hotline for assistance.

Does the GM Supplier Discount expire? discount on used or certified pre-owned vehicles?

The authorization number generated from your code expires, but the company code itself does not change often. However, eligibility can end if your company ceases to be a supplier. Always verify before starting your vehicle search.

No. The GM Supplier Discount is for new vehicles only. For certified pre-owned, you may find other promotions, but not the supplier price.
