The key distinction here is that the company itself does not receive any money from trades in the secondary market. The money goes from one investor to another.

However, the secondary market is incredibly important for the health of the primary market. It provides **liquidity**, meaning investors can easily convert their shares into cash. If you buy a stock, you want to know you can sell it quickly if needed. The secondary market guarantees that liquidity, which makes investors willing to buy shares in the primary market in the first place.

KEY PARTICIPANTS IN THE EQUITY MARKET

EXCHANGES

The reward for taking on these risks is the potential for high returns. Historically, equities have outperformed bonds, real estate, and commodities over long periods (decades), making them a cornerstone of wealth-building strategies.
