Rate Lock Information

If you have locked your interest rate, the commitment letter will include the lock expiration date and any float-down options. Rate locks typically last 30, 45, or 60 days. If your closing is delayed beyond the lock period, you may face rate extension fees or a higher rate. Closing Cost Estimate

The commitment letter often includes an estimate of closing costs, including lender fees, third-party fees, prepaid items, and escrow deposits. This section may reference the Loan Estimate form you received earlier. Review these costs carefully and ask your lender about any fees that seem unusually high or unexpected.
