1. Bonds Payable and Long-Term Debt

- **Answer Explanation:** First, calculate the annual interest payment: $\$500,000 \times 8\% = \$40,000$. The effective interest expense for the first year is $\$461,000 \times 10\% = \$46,100$. The discount amortization is $\$46,100 - \$40,000 = \$6,100$. Therefore, the carrying value at year-end is $\$461,000 + \$6,100 = \$467,100$. This demonstrates how the bond discount decreases over time as the carrying value approaches the face value.

2. Leases: The New Standard

Lease accounting underwent a fundamental overhaul with the introduction of ASC 842 and IFRS 16. The most significant change was the requirement for lessees to recognize most leases on the balance sheet. - **Answer Explanation:** Since the lease term is for a major part of the economic life (5 years relative to an expected life of, say, 7 years) and the present value of the payments is likely close to the fair value, this is likely a finance lease for the lessee. The initial lease liability is the present value of the 5 payments of \$10,000 at 6%, but note that payments are at the beginning of the period. Using an annuity due factor, the present value is $\$10,000 * (\text{PVAD due, 5 periods, 6\%})$. If the factor is approximately 4.465, the liability is \$44,650. The right-of-use asset is also recorded at this amount, adjusted for any initial direct costs.

3. Deferred Income Taxes

Deferred tax accounting is often a stumbling block for students because it requires understanding the difference between book income (financial reporting) and taxable income (tax reporting). Temporary differences arise when revenue or expense is recognized in different periods for book and tax purposes. A common question will ask you to calculate the deferred tax liability or asset at the end of the year.

- **Sample Question:** At the end of Year 1, a company has a book-tax difference related to warranty

expense. For book purposes, the company accrued \$50,000 in warranty expense. For tax purposes, warranties are only deductible when paid, and no payments were made in Year 1. The tax rate is 30%. What is the journal entry to record deferred taxes?

- **Answer Explanation:** This is a temporary difference that will reverse in future years when the warranties are paid. Since the tax deduction will be taken in the future, the company has a deferred tax asset. The journal entry is: Debit Deferred Tax Asset \$15,000 ($\$50,000 * 30\%$), Credit Income Tax Benefit (or Expense) \$15,000. This recognizes the future tax benefit in the current period.

4. Pensions and Postretirement Benefits

Pension accounting is complex, involving components like service cost, interest cost, expected return on plan assets, and prior service cost. While the details can be daunting, exam questions often focus on calculating the components of pension expense for the year or reconciling the funded status of the plan. - **Sample Question:** A company has net income of \$1,000,000 and 500,000 common shares outstanding all year. They also have 100,000 stock options outstanding with an exercise price of \$10. The average market price for the year is \$20. What is diluted EPS?
- **Answer Explanation:** First, calculate basic EPS: $\$1,000,000 / 500,000 = \2.00 . For diluted EPS, use the treasury stock method. The options would raise $\$1,000,000$ (100,000 shares * \$10). At the average market price of \$20, this would repurchase 50,000 shares ($\$1,000,000 / \20). The incremental shares are $100,000 - 50,000 = 50,000$. Diluted EPS = $\$1,000,000 /$

$(500,000 + 50,000) = \$1.82$. Note that diluted EPS is always lower than or equal to basic EPS.

HOW TO EFFECTIVELY USE PRACTICE QUESTIONS

4. **Forgetting weighted average shares:** For EPS, remember to weight shares for the portion of the year they were outstanding, including stock dividends and splits.
