Complex Financial Operations

Many financial activities are inherently multi-faceted. Payroll, for instance, involves wages, taxes, benefits, and various withholdings. COMPOUND JOURNAL ENTRIES

Example 3: Recording Accrued Expenses

At the end of an accounting period, companies must record expenses that have been incurred but not yet paid. These accruals often involve multiple accounts. For example, a company may owe its employees \$10,000 in wages for the last week of the month, and it also owes related payroll taxes of \$1,500.

The compound entry would be:

- Debit: Wages Expense for \$10,000
- Debit: Payroll Tax Expense for \$1,500
- Credit: Wages Payable for \$10,000
- Credit: Payroll Taxes Payable for \$1,500

This records the full cost of labor incurred during the period, even though cash will change hands later.

Example 4: Loan Repayment

When a business repays a loan installment, the payment typically includes both principal and interest. A

compound entry separates these components:

- Debit: Loan Payable (principal portion)
- Debit: Interest Expense (interest portion)
- Credit: Cash (total payment)

This entry ensures that the reduction in liability is recorded separately from the interest cost, which is an operating expense.

HOW TO CREATE A COMPOUND JOURNAL ENTRY STEP BY STEP

Step 5: Post to

the General Ledger

Once the compound entry is recorded in the journal, post each line item to the appropriate general ledger accounts. This step updates account balances and ensures that the trial balance remains accurate.

Step 6: Review and Verify

Always double-check your work. Verify that the sum of all debits equals the sum of all credits. Confirm that the account types are appropriate for the
