It also assumes that the purchasing power of the currency is stable over time, which is why inflation adjustments are not typically made in standard accounting. This principle simplifies recording but also means that some valuable intangible aspects of a business remain off the balance sheet.

12. The Time Period Principle

The **time period principle** divides the life of a business into regular intervals, such as months, quarters, or years, for reporting purposes. This allows stakeholders to evaluate performance on a timely basis. Without this principle, companies would only report when they shut down, which is impractical. The time period principle works hand-in-hand with revenue recognition and matching to ensure that each period's financial statements are complete and accurate.
