# 1. Vessel Types and Terminology

You need to distinguish between different types of watercraft: powerboats, sailboats, personal watercraft (PWCs), and paddlecraft. Key

terms include hull types (displacement vs. planing), propulsion systems, and capacity plates. Questions may ask about the maximum weight or number of people a boat can safely carry.

## 2. Navigation Rules (Rules of the Road)

This section covers the "Navigation Rules" often called the "Rules of the Road" - both inland and international. You must know right-of-way situations: power-driven vessels vs. sailing vessels, overtaking, crossing, and head-on encounters. Buoyage systems (red right

returning) and lateral markers are essential. Look for questions about what to do when two boats approach each other in a narrow channel or what a white light on a boat indicates at night.

## 3. Safety Equipment Requirements

California has specific regulations regarding life jackets (wearable and throwable), fire extinguishers, visual distress signals, sound-producing devices (whistle or horn), and navigation lights. The exam will ask about the number of life jackets required, who

must wear them (children under 13 on a moving vessel under 26 feet), and the types of fire extinguishers acceptable.

## 4. Pre-Departure Checks and Float Plans

Before getting underway, operators should check weather forecasts, fuel levels, engine and electrical systems, and safety gear. The concept of a float plan (leaving details with someone on shore) is often tested. You might see questions about the importance of checking the capacity plate or what to do if you run aground.

## 5. Operating Your Vessel Safely

This includes speed regulations, no-wake zones, anchoring techniques, and the dangers of alcohol and drugs. California has strict BUI (Boating Under the Influence) laws. Know the blood alcohol concentration (BAC) limit (0.08% for boats, same as cars) and penalties. Other topics: propeller strike prevention, carbon monoxide hazards, and weather awareness (e.g., what to do if a thunderstorm approaches).

## 6. Personal and Wildlife Watercraft (PWC) Protection Specific Rules

PWC operators must follow additional rules: lanyard (engine cut-off switch) attachment, no wake jumping within 100 feet of another vessel, and restrictions on operating during darkness or near swimmers. Expect at least a few questions specifically about PWCs.

California boaters must prevent the spread of invasive species (like quagga mussels), avoid disturbing wildlife (especially nesting birds and marine mammals), and properly dispose of waste. Pump-out stations for holding tanks, oil discharge laws, and no-discharge zones are common exam topics.

Procedures for towing a skier or tuber, using distress signals (flares, flags, VHF radio), and handling emergencies like man overboard, fire, capsizing, or flooding. Know the "Reach, Throw, Row, Go" rescue method and the proper way to call for help (mayday vs. pan-pan).

## EFFECTIVE STRATEGIES FOR STUDYING - NOT JUST LOOKING FOR ANSWERS

red buoy on your starboard side while entering a channel from the sea, which side of the buoy should you keep your vessel?

3. **Question:** What is the legal blood alcohol concentration (BAC) limit for operating a vessel in California?

**Answer:** 0.08% – the same as for driving a car. Under 21, any detectable alcohol can result in penalties.

4. **Question:** A PWC must be operated at what distance from a swimmer unless at slow, no-wake speed?

**Answer:** At least 100 feet from a

swimmer or another vessel (unless in a designated area).

5. **Question:** Which of the following is the most important step if your boat capsizes?

**Answer:** Stay with the boat if possible – it provides flotation and is easier for rescuers to spot.

These examples cover only a fraction of the material. The real exam has 30 to 50 questions depending on the course provider, but the topics are consistent.

---

## COMMON PITFALLS AND HOW TO AVOID THEM

---

Many test-takers make simple mistakes. Avoid these:

- **Overlooking California-specific laws.** Federal rules are similar, but

California has unique requirements (e.g., no wake within 100 feet of a swimmer, mandatory boater education). The exam emphasizes state law.

- **Confusing port and starboard.**

Use a mnemonic: “Port has four letters, left has four letters” or remember that the red light is on the port (left) side.

- **Forgetting about PWC**

**lanyards.** Always attach the engine cut-off switch lanyard to your life jacket or wrist – this is a common test item.

- **Ignoring weather questions.**

Cold water immersion, hypothermia, and lightning safety are frequent topics. Know that if you see lightning, stay low in the

boat, avoid metal, and head to shore.

- **Rushing through the exam.**

Read each question twice. Look for words like “except,” “not,” or “always.” They can change the answer completely.
