## UNDERSTANDING THE NYS COMMON CORE MATH CURRICULUM: A COMPREHENSIVE OVERVIEW

## Core Math Curriculum

The driving philosophy behind the Common Core was to ensure that students, regardless of their zip code, would have access to the same high-quality mathematical education, preparing them for college and careers in a competitive global economy.

New York was an early adopter of these standards, and the state developed its

own version, known as the New York State P-12 Common Core Learning Standards for Mathematics. This curriculum built upon the foundational Common Core framework while incorporating specific adjustments to align with New York's unique educational priorities. At its heart, the curriculum aimed to move away from rote memorization and toward a deeper, more conceptual understanding of mathematical principles.

## Why New York Adopted

# the Common Core Standard

The decision to adopt the Common Core standards in New York was driven by several factors. First, there was a widespread recognition that previous state standards varied dramatically in quality and rigor. A student in New York might be deemed proficient under state tests while a student in another state with higher standards might not. The Common Core promised a level playing field. Second,

the standards were developed by a consortium of experts, including mathematicians, educators, and researchers, which lent them significant credibility. Third, the federal Race to the Top grant program incentivized states to adopt college- and career-ready standards, providing a financial impetus for the transition. For New York, adopting the **NYS Common Core Math Curriculum** was seen as a crucial step toward modernizing its education system.

---

## THE SHIFT IN MATHEMATICAL PEDAGOGY

---

One of the most noticeable changes brought by the **NYS Common Core Math Curriculum** was a

fundamental shift in how mathematics was taught. The traditional approach often emphasized procedural fluency—memorizing formulas and performing calculations quickly. The Common Core, however, placed a premium on conceptual understanding and problem-solving.

## Focus on Depth Over Breadth

Under the previous standards, math curricula were often described as "a mile wide and an inch deep." The Common Core sought to reverse this by focusing on

fewer topics at each grade level but covering them in much greater depth. For example, instead of introducing a dozen different types of fractions operations in a single year, the curriculum might focus on a core set of fraction concepts, ensuring students truly understood the underlying principles before moving on. This approach was designed to build a stronger foundation for advanced mathematics.

## The Three Pillars of

# Mathematical Proficiency

The **NYS Common Core Math Curriculum** is built around three key shifts in instruction:

- **Greater Focus:** Teachers concentrate on the most critical concepts at each grade level, allowing students to master essential skills before moving forward.
- **Coherence:** Concepts are logically sequenced and connected across grades. Learning

is designed to build upon itself, creating a coherent narrative from kindergarten through high school.

- **Rigor:** Rigor under the Common Core means a balance of three components: conceptual understanding (knowing why), procedural fluency (knowing how), and application (knowing when to use it).

This tripartite approach meant that students were no longer just expected to get the right answer; they were expected to explain their reasoning, justify their methods, and apply their

knowledge to novel, real-world problems.

## **KEY COMPONENTS OF THE NYS COMMON CORE MATH CURRICULUM**

---

To fully appreciate the curriculum, it is helpful to understand its two primary structural components: the Content Standards and the Standards for Mathematical Practice.

# Content Standards: What Students Should

## Know

The Content Standards specify the mathematical knowledge and skills students should acquire at each grade level. These are organized into domains and clusters. For example, in Grade 3, domains include Operations and Algebraic Thinking, Number and Operations in Base Ten, Number and Operations—Fractions, Measurement and Data, and Geometry. Each domain contains specific, measurable standards. A typical Grade 3 standard might read: "Interpret products of whole numbers, e.g., interpret  $5 \times 7$  as the total number of objects in 5 groups of 7 objects

each." This example illustrates the emphasis on conceptual understanding from the very beginning.

# Standards for Mathematical Practice: How Students Learn

Perhaps the most innovative aspect of the **NYS Common Core Math Curriculum** is the inclusion of the Standards for

Mathematical Practice. These eight overarching habits of mind describe the processes and proficiencies that mathematically proficient students should develop over time:

1. **Make sense of problems and persevere in solving them.**
2. **Reason abstractly and quantitatively.**
3. **Construct viable arguments and critique the reasoning of others.**
4. **Model with mathematics.**
5. **Use appropriate tools strategically.**
6. **Attend to precision.**
7. **Look for and**

**make use of structure.**

8. **Look for and express regularity in repeated reasoning.**

These practices are woven into every lesson. A student might be asked to explain how they solved a problem, defend their answer to a peer, or draw a visual model to represent a complex concept. This shift from passive learning to active engagement was a hallmark of the curriculum.

---

## **IMPLEMENTATION ACROSS NEW YORK STATE**

---

The rollout of the **NYS Common Core Math Curriculum** was ambitious and, at times, turbulent. The New York State

Education Department (NYSED) embarked on a multi-year implementation plan that included professional development for teachers, the development of new curriculum materials, and the creation of aligned assessments.

## **Timeline of Key Milestone S**

- **2010:** New York formally adopts the Common Core Standards.
- **2011-2012:** Pilot year for the new standards in some districts; initial professional

development begins.

- **2013:** Full implementation of the Common Core standards begins in all K-12 classrooms. The first state assessments aligned to the new standards are administered.
- **2014-2015:** The new assessments become mandatory, and student scores drop dramatically, reflecting the increased rigor of the curriculum.
- **2015-2017:** Growing public backlash and the opt-out movement lead to a review of the standards.
- **2017:** New York

begins the process of revising the Common Core standards, leading to the creation of the Next Generation Learning Standards.

## Challenges Faced During Implementation

The transition was not smooth. Many districts were inadequately prepared. Teachers, who were used to a different pedagogical approach, sometimes received insufficient training on how to

teach the new curriculum effectively. Parents were often baffled by the new math methods, which seemed foreign compared to the algorithms they had learned as children. The so-called "new math" techniques—like number bonds, tape diagrams, and the area model for multiplication—became a source of widespread frustration and confusion.

---

### **THE CONTROVERSY AND PUBLIC RESPONSE**

---

No discussion of the **NYS Common Core Math Curriculum** is complete without acknowledging the significant controversy it generated. While the intentions behind the standards were broadly

supported, the execution led to a strong backlash.

## **Parental Concerns and the "New Math" Problem**

Many parents felt alienated from their children's education. When a second-grade student came home with a worksheet asking them to add 23 and 45 using a "number bond" or a "ten-frame," parents often could not help. The methods were unfamiliar, and the homework became a

source of nightly stress. Critics argued that the curriculum was developmentally inappropriate for younger students and that it placed too much emphasis on abstract reasoning before students had mastered basic facts.

## The Opt-Out Movement

Perhaps the most potent manifestation of public discontent was the opt-out movement. Beginning around 2014, a growing number of parents chose to have their children refuse the state-administered standardized tests

aligned with the Common Core. New York became the epicenter of this movement, with tens of thousands of students opting out each year. This was a powerful statement of protest against what many saw as an over-reliance on high-stakes testing and a curriculum that was being implemented too quickly without adequate support.

---

### IMPACT ON STUDENT PERFORMANCE

---

Assessing the true impact of the **NYS Common Core Math Curriculum** on student performance is complex. Data from the early years of implementation showed a predictable pattern: scores on the new, more rigorous

tests dropped significantly compared to the previous state assessments. This was expected, as the new tests measured a different, deeper level of understanding.

## NAEP Scores and Long- Term Trends

Looking at the National Assessment of Educational Progress (NAEP), often called "The Nation's Report Card," provides a more objective picture. In the years following full implementation, New York's NAEP math scores for 4th grade showed modest gains,

while 8th-grade scores remained relatively flat. These mixed results suggest that while the curriculum may have benefited some students, particularly in the early grades, it did not produce the transformative gains that proponents had hoped for. The gap between high-performing and low-performing students also persisted, raising questions about equity.

---

### **THE EVOLUTION: NEXT GENERATION LEARNING STANDARDS**

---

Recognizing the challenges and feedback from parents, teachers, and administrators, New York State embarked on a formal review of the Common Core standards in 2015. The

result was the development of the Next Generation Learning Standards, which were finalized in 2017 and fully implemented by the 2020-2021 school year.

# What Changed with the Next Generation Standards?

The Next Generation Standards are not a complete rejection of the Common Core but rather an evolution.

The core philosophy of conceptual understanding, problem-solving, and the Standards for Mathematical Practice remains largely intact. However, significant changes were made to improve clarity, age-appropriateness, and teachability. For instance:

- **Reduced number of standards:** Some standards were consolidated or removed to reduce clutter and allow for more focused instruction.
- **Increased clarity:** The language of the standards was revised to be more explicit and easier for teachers and

parents to understand.

- **Developmentally appropriate pacing:** Some topics were moved to different grade levels to better align with child development research.
- **Emphasis on fluency:** The Next Generation standards placed a renewed emphasis on fluency with basic math facts, addressing a common criticism that the Common Core had neglected memorization.

The **NYS Common Core Math Curriculum** laid the groundwork, but the Next Generation Learning Standards

represents a more refined, responsive version of those original goals.

---

### **BEST PRACTICES FOR SUPPORTING STUDENTS IN THIS MATHEMATICAL LANDSCAPE**

Whether a school is still using materials rooted in the Common Core or has fully transitioned to the Next Generation standards, the underlying approach to math instruction remains similar. Here are some practical ways parents and educators can support students:

- **Embrace the "Why":** Instead of just asking for the answer, ask your child to explain \*how\* they got it. This

builds the conceptual understanding that is central to this curriculum.

- **Use Visual Models:** Draw pictures, use number lines, or build
