### DERIVATION OF THE MAGNITUDE AND DIRECTION

To understand why the formula works, consider the parallelogram with sides **A** and **B** and included angle  $\theta$ . The diagonal **R** can be found using the law of cosines in the triangle formed by the two

sides and the diagonal. In triangle  $OAC$ , where  $OA = A$ ,  $OC = \mathbf{R}$ , and the side  $AC$  is parallel and equal to  $\mathbf{B}$ :

- Side  $AC = B$
- Angle at  $O$  is  $\theta$
- Angle at  $A$  is  $(180^\circ - \theta)$  – but it is easier to use the law of cosines directly on the parallelogram's triangle: In triangle  $OAB$  (but note that the diagonal splits the parallelogram into two triangles).

A cleaner derivation: In triangle  $OAC$ , the side  $AC$  equals  $B$  and the angle  $\angle OAC$  equals  $180^\circ - \theta$ . However, applying the law of cosines to triangle  $OAB$  (where side  $OB = B$ , side  $AB = ?$ ) can be confusing. The standard approach uses the fact that in the triangle formed by the two vectors and the resultant, the

angle between  $\mathbf{A}$  and  $\mathbf{B}$  is  $\theta$ . The resultant is the third side. Using the law of cosines:

$$|\mathbf{R}|^2 = |\mathbf{A}|^2 + |\mathbf{B}|^2 - 2|\mathbf{A}||\mathbf{B}| \cos(180^\circ - \theta)$$

Since  $\cos(180^\circ - \theta) = -\cos \theta$ , this becomes:

$$|\mathbf{R}|^2 = A^2 + B^2 + 2AB \cos \theta$$

Taking the square root gives the magnitude formula. For direction, consider the right triangle formed when dropping a perpendicular from the tip of  $\mathbf{B}$  to the extension of  $\mathbf{A}$ . The component of  $\mathbf{B}$  along  $\mathbf{A}$  is  $B \cos \theta$ , and the perpendicular component is  $B \sin \theta$ . The resultant's angle  $\alpha$  from  $\mathbf{A}$  satisfies:

$$\tan \alpha = (B \sin \theta) / (A + B \cos \theta)$$

### Engineering and Physics

## PARALLELOGRAM LAW VS. TRIANGLE LAW

To check your work, remember that the

resultant magnitude lies between the difference and the sum of the two magnitudes:  $|A - B| \leq R \leq A + B$ . If your computed  $R$  falls outside this range, you likely made an error.
