HOW TO START A LAUNDROMAT BUSINESS: A STEP-BY-STEP GUIDE TO BUILDING A PROFITABLE VENTURE

2. Create a Detailed Business Plan

3. Secure Financing

Prepare a strong loan application with your business plan, personal credit score (aim for 680+), collateral, and financial statements. SBA 7(a) loans are popular for laundromat

4. Choose the Right Location and Lease

Check local zoning laws and building codes. Some areas require specific permits

for laundromats due to water usage and wastewater discharge. Hire a commercial real estate agent familiar with the industry to help you evaluate options.

5. Purchase and Install Equipment

The heart of your laundromat is its machines. Invest in high-quality, energy-efficient commercial washers and dryers from reputable brands like Speed Queen, Dexter, or Huebsch.

Choose the right mix of sizes: small top-loaders for households, large front-loaders for comforters and bulky items, and perhaps a few oversized machines for rugs and dog beds.

Plan for about 1,000 to 1,200 square feet of floor space per 20-30 machines. Calculate the required electrical service (typically 400-600 amps for a medium-sized operation) and ensure the building can handle the load. Install a coin, card, or mobile payment system. Modern card readers and app-based payments reduce theft and improve customer convenience.

Don't forget ancillary equipment: coin changers, vending machines (detergent, fabric softener,

snacks), folding tables, seating, carts, and a television or Wi-Fi for customer comfort. Plan a preventative maintenance schedule to minimize downtime.

6. Obtain Licenses, Permits, and Insurance

Every city and state has specific requirements for starting a laundromat business. Common licenses include a general business license, sales tax permit, and health department approval (especially if you offer wash-and-fold service). You may also need a

water discharge permit if your facility sends wastewater into the municipal system.

Insurance is non-negotiable. Obtain general liability insurance, property insurance for the building and contents, workers' compensation (if you hire employees), and equipment breakdown coverage. Umbrella liability policies are also wise. Your insurance agent can help you assess risks based on your specific location and services.

7. Hire and Train Staff

While many laundromats operate as self-service, having

staff on-site improves security, maintenance, and customer service. Consider hiring attendants for peak hours (mornings and evenings) and a manager to oversee daily operations. If you offer drop-off laundry services, you'll need additional staff for sorting, washing, folding, and packaging.

Train employees on machine operation, safety protocols, cleaning procedures, and customer service. Create an employee handbook covering dress code, cash handling, and emergency responses. Background checks are recommended for staff handling money and customer belongings.

Typical self-service rates range from \$2 to \$5 per load for washing and \$0.25 to \$0.50 per 10 minutes for drying. Wash-and-fold services usually charge by the pound (\$1.50–\$2.50/lb).

Use a point-of-sale (POS) system that tracks revenue, machine usage, and expenses. Many modern machines connect to cloud-based management software,

allowing you to monitor performance remotely. Implement cashless payments to reduce theft and provide convenience—credit cards, Apple Pay, and laundromat-specific apps are popular.

Set aside a portion of revenue for maintenance and emergency repairs. A common rule is 5-10% of gross income for machine upkeep and building improvements.
