# Requirement 1: The Foundational Commitment

## ent

Before you begin any physical activity, the workbook asks you to understand the basics. This includes discussing with your counselor the potential risks, the importance of a medical check-up, and the commitment of 12 weeks. Your "answer" here is not a written paragraph but rather a documented conversation. You simply need to have your counselor sign off that this discussion took place. However, it's wise to write a brief note in your workbook about what you discussed to help you remember the key points.

# Requirement 2: Your Health History

This is a critical section. You will complete a health history form, which typically includes questions about your family history of heart disease, diabetes, and other conditions, as well as your own medical history (asthma, injuries, etc.).

**Honesty is crucial here.** The "answers" in this section are your personal facts. If you have a history of knee pain, writing it down helps you and your counselor design a

fitness plan that is safe and effective. Do not guess. If you are unsure about a family health condition, ask your parents or guardian. This information helps you understand your own baseline risks.

# Requirement 3: The Pre-Program Physical Assessment

This is where you start collecting data. You will need to have a complete medical checkup by a licensed

healthcare provider (doctor, nurse practitioner, or physician's assistant). The provider will fill out a section of the workbook confirming you are physically fit to begin a 12-week exercise program. This is a non-negotiable step for safety. The "answer" here is the physician's clearance. Without it, you cannot proceed.

## Requirement 4: The Initial Fitness Tests

Now you get to measure your starting point. The workbook outlines several fitness

tests that you must perform before starting your program. These include:

- **Aerobic Fitness (12-Minute Run/Walk):** How far can you go in 12 minutes? Record the distance.
- **Flexibility (Sit-and-Reach Test):** How far can you reach? Record the inches.

## Requirement 5: The Daily Log – Your 12-

## Week Journey

This is the heart of the workbook. You will be required to keep a daily log of your physical activity for at least 12 consecutive weeks. This log often includes:

- **Date and Time:** When did you exercise?
- **Type of Activity:** (e.g., jogging, swimming, cycling, walking, weight lifting)
- **Intensity:** How hard were you working? You can record your perceived exertion (e.g., 1-10 scale) or your actual heart rate.



- **Duration:** How long did you exercise for? (e.g., 30 minutes)

## Requirement 6: Creating Your Personal Fitness Plan

After you have your baseline scores and have perhaps discussed your goals with your counselor, you will write a formal fitness plan. This is a more detailed "answer" section of the

- **Your Goal:** "I want to improve my 12-minute run time by 0.5 miles." or "I want to increase my push-ups from 10 to 25."
- **Frequency:** How many days per week will you exercise?
- **Intensity:** What will your target heart rate be?

- **Time (Duration):** How long will each session be?

This is often called the FITT principle. Your

plan should be realistic and safe. If you have never run before, your plan should start with walking and slowly introduce jogging intervals. Your "answers" should reflect a thoughtful, progressive approach.

## Requirement 7 & 8: Mid-Program and Final Assessments

The workbook will ask you to repeat the fitness tests from Requirement 4 at specific intervals,

typically halfway through (week 6) and at the end (week 12). Your "answers" are your new scores. Compare them with your initial scores. Did you improve? In which areas? This data is incredibly powerful. It shows you the direct result of your hard work. It is also common to see improvement in one area (like aerobic fitness) but not another (like flexibility). This is normal and provides valuable information for your future fitness journey.

### **PROVIDING THOUGHTFUL ANSWERS FOR THE REFLECTIVE SECTIONS**

---

Beyond the data, the workbook also asks for your thoughts and reflections. For example, you might be

asked:

- "What did you learn about the importance of proper nutrition?"
- "How did you feel after starting this program?"
- "What challenges did you face, and how did you overcome them?"
- "How has this experience changed your attitude toward physical fitness?"

This is where you can write genuinely personal "answers." Do not copy generic phrases from online sources. The best answer is your own story. For example:

*"I learned that I need to eat a healthier breakfast. I used to skip it, but I felt tired*

*during my morning runs. I started eating oatmeal with fruit, and my energy levels improved dramatically. I also realized that drinking enough water is just as important as the exercise itself."*

This kind of honest reflection shows the merit badge counselor that you have truly engaged with the material.

## COMMON PITFALLS TO AVOID WHEN USING THE WORKBOOK

---

- **Filling it out the night before:** A 12-

- **Not listening to your body:** The workbook is a guide, not a punishment. If you are injured, you need to rest. Record the rest days honestly and explain why you rested.
