For instance, a high long-term fuel trim may indicate a vacuum leak or a faulty MAF sensor. Graph the data in real

time to identify intermittent faults.

Freeze Frame Review

When a DTC sets, the ECU records a freeze frame. Reviewing this snapshot shows engine speed, coolant temperature, vehicle speed, and other conditions at the moment of failure. This helps duplicate the problem during testing.

Component Activation

Tests

Many professional scanners allow you to command actuators like fuel injectors, idle air control motors, or EVAP purge valves. This is an essential **diagnostic technique** to verify wiring and component operation without starting the engine.

Monitors Readiness Check

After performing repairs, check which monitors are complete. Some monitors require specific driving conditions (e.g., highway speed, cold start) to run. Technicians often follow a manufacturer's

This monitor checks the internal heater circuit of oxygen sensors. It measures current draw and resistance. A failed heater increases warm-up time, leading to rich

mixtures and poor fuel economy. The monitor will set a code like P0030 (HO2S heater control circuit).

Evaporative Emission (EVAP) System Monitor

The EVAP monitor tests for fuel vapor leaks by pressurizing the system. It uses a purge valve, vent valve, and fuel tank pressure sensor. The monitor runs only when the engine is cold and the vehicle is at a steady speed. If a leak as small as 0.02 inches is

detected, a DTC like P0455 (gross leak) is stored.

use advanced methods to isolate intermittent and complex issues.

Secondary Air Injection Monitor

Wiring and Connector

Found on some vehicles, this monitor checks the operation of the air pump that injects air into the exhaust during cold starts to speed up catalyst light-off. If airflow is insufficient, the monitor sets a code and fails readiness.

Diagnostics

OBD II communication relies on the CAN bus or other protocols. Use a multimeter or oscilloscope to check for correct voltage, ground, and signal integrity at the DLC. No communication? Check power, ground, and the network termination resistors.

ADVANCED DIAGNOSTIC TECHNIQUES USING OBD II

Beyond basic code reading, professionals

Mode \$06 provides raw test results from each monitor. For example, the catalyst monitor may report a numerical "TID" (Test ID) and "CID" (Component ID) with a pass/fail threshold. This data allows you to see how close a component is to failing before a code sets. It is one of the most nuanced **diagnostic techniques** available through advanced scan tools.

Some OBD II issues are best observed with waveforms. For example, a crankshaft position sensor signal can be graphed to detect missing teeth or intermittent dropout. Connecting a scope to the OBD II connector's pins can reveal CAN bus errors causing communication failures.
