## SAMPLE PROBLEMS FROM A TYPICAL SOLVING EQUATIONS AND FORMULAS WORKSHEET

## Problem 1: Linear Equation

**Solve for x:**  $4x - 7 = 2x + 11$

## Problem 3: Quadratic Equation

**Solve for x:**  $x^2 - 6x + 8 = 0$

**Solution:** Factor:  $(x - 2)(x - 4) = 0$ . Set each factor to zero:  $x - 2 = 0 \rightarrow x = 2$ ;  $x - 4 = 0 \rightarrow x = 4$ . The solutions are  $x = 2$  and  $x = 4$ .

## Problem 4: System of Equations

**Solve the system:**  $y = 2x + 3$  and  $3x - y = 5$

**Solution (substitution):** Substitute  $y = 2x + 3$  into the second equation:  $3x - (2x + 3) = 5 \rightarrow 3x - 2x - 3 = 5 \rightarrow x - 3 = 5 \rightarrow x = 8$ . Then  $y = 2(8) + 3 = 19$ . Solution:  $(8, 19)$ .

These examples demonstrate the variety of techniques a single worksheet may encompass. By working through such problems, students build a mental toolkit for tackling any equation they encounter.

### COMMON PITFALLS AND HOW TO AVOID THEM

---

Even with diligent practice, certain mistakes recur frequently. Being aware of them can drastically improve accuracy.

- **Forgetting to Distribute**  
**Negatives:** A minus sign outside parentheses can trip up many. For example, solving  $-3(x - 4) = 18$  requires distributing the negative:  $-3x + 12 = 18$  (not  $-3x - 12$ ).
- **Adding Instead of Subtracting:**  
When moving a constant to the other side, perform the inverse operation. If the constant is positive, subtract; if negative, add.
- **Misapplying the Order of Operations:** In multi-step equations, always perform operations in reverse PEMDAS

when isolating the variable. That means undo addition/subtraction first, then multiplication/division.

- **Ignoring the Domain:** In rational and radical equations, check for extraneous solutions—those that make a denominator zero or a radicand negative.
- **Not Simplifying Completely:**  
Sometimes a final expression like  $x = (12/(2+3))$  can be simplified to  $x = 12/5$  or 2.4. Always reduce fractions and decimals appropriately.
