5. Warranties of Title

- **Covenant of Seisin:** The grantor owns the property and has the legal right to convey it.
- **Covenant of**

Right to

Convey: The grantor has the authority to transfer the title.

- **Covenant Against Encumbrances:**

There are no undisclosed liens, easements, or encumbrances.

- **Covenant of Quiet Enjoyment:** The grantee will not be disturbed by third-party claims.

- **Covenant of Warranty:** The grantor will defend the title against lawful claims.

- **Covenant of Further Assurances:** The grantor will do anything necessary to

perfect the title.

These warranties extend back through the entire chain of title, giving the buyer maximum protection.

6. Signature and Notarizati on

Texas law requires the grantor (or their authorized representative) to sign the deed in the presence of a notary public. The notary must verify the signer's identity and witness the signature. While the grantee does not need to sign, recording the deed

requires proper notarization. Two witnesses are not required in Texas, but some title companies may request them for added security.

7. Recordin g Informati on (often left blank)

After execution, the deed must be filed with the county clerk in the county where the property is located. The document will include spaces for the clerk to stamp the

instrument number, volume, and page. Recording puts the world on notice of the ownership change and establishes priority under Texas recording laws.

DIFFERENCES BETWEEN GENERAL WARRANTY DEED AND SPECIAL WARRANTY DEED IN TEXAS
